**LEGAL DEFINITION FOR CHILD SEXUAL ABUSE USED BY  
MASSACHUSETTS CHILD PROTECTION AGENCY (DSS)**

**“The non-accidental commission of any act by a caretaker\* upon a child under age eighteen (18) which causes, or creates a substantial risk of physical or emotional injury, or constitutes a sexual offense under the laws of the Commonwealth or any sexual contact between a caretaker and a person under the care of that individual. This definition is not dependent upon location (i.e., abuse can occur while the child is in an out-of-home or in-home setting).”**

**GUIDANCE ON REPORTING TO MASSACHUSETTS CHILD PROTECTION  
AGENCY (DSS) AND LAW ENFORCEMENT**

**If you are concerned that a child may be the victim of any type of abuse or neglect, please call the Department of Social Services (DSS) immediately. It is not uncommon to feel unsure about whether a situation is abusive or neglectful; if you are in doubt, contact DSS. A qualified professional is available 24 hours a day to address your concerns.**

**All reports of abuse or neglect received by DSS are processed by appropriately trained, experienced staff. Based on the information received, DSS will determine whether or not there is reasonable cause to believe the reported children have been abused or neglected by their parents or caretakers\*. If reports do not meet DSS’s criteria of abuse or neglect, the reports are screened out. Reports may also be screened out if the identified, alleged perpetrators are not caretakers. In those cases, if DSS believes children have been hurt or neglected by individuals, who are not caretakers of the children, DSS can offer services to the families. The families will also be encouraged to call the police or other appropriate authorities (e.g. District Attorney). Additionally, DSS may need to make mandatory or discretionary referrals to the offices of the local District Attorneys.**

**\*A “caretaker” is any person entrusted with the responsibility for a child’s health or welfare, both in and out of the home, regardless of age. *(Adapted from the DSS brochure: Child Abuse and Neglect Reporting: A Guide for Mandated Reporters, 2000)***

The Sex Offender Registry Board (SORB) is the state agency responsible for identifying who must register as a sexual offender and how long do they have to register; assessing a classification level for each offender based on their risk to re-offend and the degree of dangerousness they pose to public safety and; assisting local police departments provide information to the public about potentially dangerous sexual offenders who live, work, or attend post-secondary institutes of higher education.

The SORB's Victim Service Unit provides assistance to victims who choose to participate in the classification of his or her convicted assailant. For more information, please call the Victim Service Unit at (978) 740-6441.

The goal of the Sex Offender Registry is to prevent further victimization by releasing to the public information about known sexual offenders and working closely with other federal, state, and private agencies to educate the public about identifying sexual offenders and preventing the further perpetration of sexual offenses.

The SORB web site is a comprehensive resource for professionals and concerned citizens to find information including but not limited to:

1. What are considered to be Sexual Offenses in Massachusetts?
